

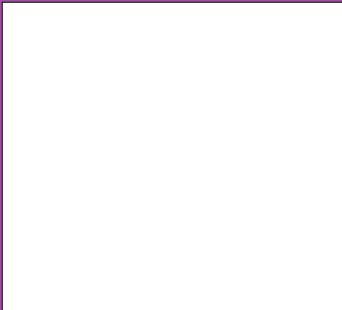

Medidata helped PCMG Highlight some Key Elements in October's Basel Workshop in October.

- A good cost grid - more than just a selection tool & can save £m's when integrated into the project management and oversight process
- Contrasts in the construction centre showed how Pharma leads in transparency of bids but behind in partnership management.
- There remains vast untapped potential to use IT to improve financial management including in areas that are 'accounting responsibilities'
- Who 'owns' Investigator access - are Registries a benefit or threat?
